All citizens are advised that the Central County Transportation Authority has prepared an application for State of Michigan financial assistance for fiscal year 2018 as required under Act 51 of the Public Acts of 1951, as amended, and for federal assistance as required under the Federal Transit Act, as amended.

The Central County Transportation Authority is requesting a total of \$7,372,605 through the sources identified below. Capital projects are proposed for funding 80% Federal and 20% State of Michigan.
