PUBLIC TRANSPORTATION SERVICES AVAILABLE IN KALAMAZOO

Metro provides three types of public transportation services in Kalamazoo: Metro, accessible, fixed-route service; county-wide Metro Connect service; and ADA Access paratransit service. For information about the fixed-route service, call 269-337-8222 or visit www.kmetro.com.

For individuals who are unable, as a result of a disability, to use the accessible bus service some or all of the time, *Access* provides origin-to-destination transportation service. This service is assured under the Americans with Disabilities Act (ADA).

VISITORS TO KALAMAZOO

If you are visiting Kalamazoo, you may be eligible to use ADA *Access* service.

- If you are certified as ADA eligible in the community in which you live, you have access to Kalamazoo's paratransit service while you are visiting our community. Please complete this Visitor's Pass Request.
- If you have not been certified as ADA eligible in your county of residence, but are qualified for this service, complete the attached Visitor's Pass Request. You will need to provide evidence of your visitor status and proof of your disability, if it is not readily apparent.

Certification Process

To use Kalamazoo's *Access* service, you must be certified or request a Visitor's Pass. A request form is included in this brochure. Applications for permanent certification are available by contacting Metro, 530 N. Rose Street, Kalamazoo, MI 49007-3638, (269) 337-8477.

Reservations

Once you have a Visitor's Pass or are certified to use Metro Connect service, call 269-350-2970 to make a trip reservation. Reservations may be made between 8 a.m. and 5 p.m. 7 days a week and up to 7 days in advance.

Service Days and Hours

Metro Connect service is provided from 6:00 a.m. to 12:15 a.m., Monday through Friday; 6:00 a.m. to 10:15 p.m. Saturday; and Sunday from 8:00 a.m. to 6:00 p.m.

Service Area

Metro Connect provides service to all of Kalamazoo County and the Veteran's Administration Hospital in Battle Creek. The ADA service area is 3/4 of a mile beyond the fixed-route service.

Cost Per Trip

Each one-way ADA trip costs \$3.00. Countywide service is \$4.00 per trip if you are certified.

Your Visitor's Pass will be good for 21 days of service in one year. If you need more than 21 days of service, or if you are moving to this area, you will need to fill out an application to become eligible to use this service on a permanent basis.
