# PUBLIC TRANSPORTATION SERVICES AVAILABLE IN KALAMAZOO

Kalamazoo Metro Transit provides there types of public transportation services: **Metro Transit** accessible, fixed-route service; county-wide **Metro County Connect** service; and **ADA Access** paratransit service. For information about the fixed-route service, call (269) 337-8222.

For individuals who are unable, as a result of a disability, to use the regular accessible bus service some or all of the time, *Access* provides origin-to-destination transportation service. This service is assured under the Americans with Disabilities Act (ADA).

# **VISITORS TO KALAMAZOO**

If you are visiting Kalamazoo, you may be eligible to use ADA *Access* service.

- If you are certified as ADA eligible in the community in which you live, you have access to Kalamazoo's paratransit service while you are visiting our community. Please complete the Visitor's Pass Application.
- If you have not been certified as ADA eligible in your county of residence, but are qualified for this service, complete the attached Visitor's Pass Request. You will need to provide evidence of your visitor status and proof of your disability, if it is not readily apparent.

# ADA ACCESS SERVICE

#### **Certification Process**

To use Kalamazoo's *Access* service, you must be certified or request a Visitor's Pass. A request form is included in this brochure. Applications for permanent certification are available by contacting Metro Transit, 530 N. Rose Street, Kalamazoo, MI 49007-3638, (269) 337-8477.

#### Reservations

Once you have a Visitor's Pass or are certified to use Metro County Connect service, call 350-2970 to make a trip reservation. Reservations may be made between 8 a.m. and 5 p.m. 7 days a week and up to 7 days in advance.

# Service Days and Hours

Metro County Connect service is provided from 6:00 a.m. to 12:15 p.m., Monday through Friday; 6:00 a.m. to 10:15 p.m. Saturday; and Sunday from 8:00 a.m. to 5:00 p.m.

#### Service Area

Metro County Connect provides service to all of Kalamazoo County and the Veteran's Administration Hospital in Battle Creek. The ADA service area is 3/4 of a mile beyond the fixed-route service.

### **Cost Per Trip**

Each one-way ADA trip costs \$3.00

# **WELCOME TO KALAMAZOO**

Welcome to the City of Kalamazoo! If you have transportation needs in our community you may want to consider using Kalamazoo Metro Transit's Metro County Connect service.

Metro County Connect *Access* service is for individuals who cannot use Metro Transit regular fixed-route bus service because of a disability. If you have moved to Kalamazoo but have been here less than 21 days, or if you are visiting and are interested in transportation services, complete the attached request form.

Bring or mail the completed form and verification of address and disability (if your disability is not readily apparent) to our office at 530 N. Rose Street to be entered into our scheduling system. If you have written verification of your disability, you can make your request by mail to:

Your Visitor's Pass will be good for 21 days of service. If you need more than 21 days of service, or if you are moving to this area, you will need to fill out an application to become eligible to use this service on a permanent basis. Applications are available at our office or can be mailed upon request (call 337-8477).
